The Deputazione di storia patria per il Friuli was established by a Lieutenant Decree of 15 December 1918, with the aim of 'collecting and publishing, through the press, studies, histories, chronicles, statutes and diplomatic documents and other papers that are particularly important for the civil, military, legal, economic and artistic history of Friuli'. The Società storica pisana (Historical Society of Pisa) was founded on 9 May 1930, with the aim of 'promoting studies on the history of Pisa or, in any case, relating to the history of Pisa, and to carry out research, conservation, publication and illustration of the relevant historical material. To also spread knowledge of Pisan history and art'. The Deputazione di Storia Patria per le Marche was also established in 1890 to operate in the field of historical research at a regional level. The statute in force since 1991 indicates the purpose of 'promoting research and studies on the history of the region, under every aspect in the context of Italian and European history', through the publication of sources and studies, public scientific meetings, conferences and congresses aimed at illustrating and preserving the historical memories of the Marche. In these and similar institutions there is a strong link between places and the impulse of historical research at a scientific level, with a particular focus on dissemination and presence in the territory. How can this traditional commitment be combined with the typical demands of public history? What new awareness and practices should be undertaken? This Panel aims to initiate a concrete and factual reflection.
